

**PUBLIC NOTICE** is hereby given that the City of Coral Gables, Planning and Zoning Board (PZB) will conduct a workshop on August 13, 2014 on the following draft Zoning Code text amendments at the Coral Gables City Commission Chambers, City Hall, 405 Biltmore Way, Coral Gables, Florida:

**Presentation of Mediterranean Village Form Based Code Overlay District.** The Planning and Zoning Division is not seeking a recommendation at this time. The purpose of this workshop is to present the draft Zoning Code text amendments and preliminary development regulations for the Mediterranean Village Form Based Code Overlay District. These development provisions will be utilized for the proposed "Urban Village at Ponce Circle" project (formally known as "Old Spanish Village"). The Mediterranean Village Form Based Code Overlay District is envisioned as a separate subsection of Zoning Code Article 3, "Development Review", Division 5, "Planned Area Development". These Zoning Code text amendments and development regulations and the proposed "Urban Village at Ponce Circle" project will be scheduled for presentation at a future Board meeting as a public hearing item for recommendation by the Planning and Zoning Board prior to consideration by the City Commission at two (2) public hearings.

The workshop is not a public hearing. The intent of the workshop is to present and facilitate discussion on the subject topic between members of the Board and City Staff. While the public is encouraged to attend the meeting, public comment will be taken at the meeting at the discretion of the Chairman of the Board. This item will return to the Planning and Zoning Board as a public hearing item at which time the opportunity for public comment will be provided.
