I would advise committee members who are University students to file financial disclosure forms if they are 18 years old or older. The rationale is that only minors should be shown the benefit of limited legal responsibilities and greater legal protections. *See* INQ 10-123, to Pine Crest Village Clerk Guido Inguanzo, Jr.

If the University students qualify as "dependent students" claimed by their parents on IRS filings, the students would simply file the County Source of Income Statement indicating their personal income, if any, or "zero" if none. Assets and liabilities are not listed on the County form. Students would not be required to submit information about their parents' finances.
