RE: Legal Opinion Regarding Coral Gables Congregational Church Sculpture

Date: March 23, 2015

Pursuant to section 2-201(e)(1) and (8) of the City Code, and section 2-702 of the Zoning Code, as well as Article 6 of the Zoning Code (related to legal non-conformities), it is my opinion that the placement of the bronze religious sculpture, referred to as the "Homeless Sleeping Jesus," in the proposed location at the historic church can be approved without a variance.

To begin, I would note that at their March 12, 2015 meeting, the Board of Architects granted preliminary approval for this sculpture, including its proposed location, as being aesthetically appropriate under the circumstances. In addition, I would note that the historic building is within the front setback and, accordingly, is legally non-conforming as to its setback under Article 6 of the Zoning Code. The proposed sculpture would be placed at an aesthetically appropriate location within the setback. It is also my understanding that there is no other location on this property that would be suitable for the sculpture and that would conform with the setback restrictions. Finally, the Zoning Code recognizes the ability to place fountains, reflecting pools, planters, and flagpoles between the front of a building and the right-of-way, even if within the setback. §§ 5-120, 5-121, and 5-122, Zoning Code. Although the sculpture is not a fountain or reflecting pool, I would note this provision as it recognizes the ability to place certain structures in the front setback, which will be further addressed below.

Based on the totality of the circumstances surrounding this proposed sculpture, and based on my interpretation of the Religious Land Use and Institutionalized Persons Act, and case law interpreting the First Amendment Free Exercise clause, it is my opinion that this express religious speech should be entitled to some particular deference and accommodation in order to avoid any potential substantial burden on the free exercise of religion. This is particularly true where the site has been determined to be appropriate by the Board of Architects, there is no other suitable location outside the setback, the building itself is legally non-conforming, and a fountain or planter could be placed in the same location. Accordingly, and consistent with my authority to enforce Article VI of the Zoning Code, I recommend that you allow this proposed location for the sculpture, and I recommend that a formal variance not be required. Please note, this opinion is being issued based on RLUIPA and Article 6 of the Zoning Code, as well as the totality of the circumstances presented. Any further application of these principles to other situations would require review by the City Attorney's Office.

City Attorney Opinion
