RESOLUTION NO. 2008-201 (As Amended)

A RESOLUTION OF THE CITY COMMISSION OF CORAL GABLES AMENDING RESOLUTION 2007-245 WHICH ESTABLISHED FEES FOR VARIOUS LICENSES, PERMITS, SERVICES, AND PENALTIES BY THE CITY OF CORAL GABLES, PROVIDING FOR SEVERABILITY, AND AN EFFECTIVE DATE.

WHEREAS, Resolution No. 2006-187, passed and adopted by the City Commission on October 10, 2006 and subsequently amended by Resolution 2006-211 on December 12, 2006, Resolutioin 2007-153 on June 26, 2007 and Resolution 2007-245 on October 23, 2007 established fees for various licenses, permits, services and penalties by the City of Coral Gables; and

WHEREAS, Ordinance No. 2006-27 establishing a special revenue fund entitled "Citywide Records Management Infrastructure, Business Process Improvement: Enterprise Content Management Project" was passed and adopted by the City Commission on September 26, 2006 and is by reference made a part of this resolution; and

WHEREAS, those documents that require the one dollar (\$1.00) per page filing fee obligated by Ordinance No. 2006-27 are indicated by an asterick (*) herein; and

WHEREAS, any subsequent increases or additions to the fees contained in this resolution shall be established by the City Commission by amending this resolution; and

WHEREAS, the City Commission has determined that in order to meet rising costs and charges, it is necessary to raise fees,;

NOW THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.


