ORDINANCE NO. _____

AN ORDINANCE OF THE CITY COMMISSION OF CORAL GABLES, FLORIDA PROVIDING FOR A TEXT AMENDMENT TO THE CITY OF CORAL GABLES OFFICIAL ZONING CODE, ARTICLE 4, "ZONING DISTRICTS", ADDING "MUSEUM" AS A PERMITTED USE IN COMMERCIAL DISTRICT (C) AND INDUSTRIAL DISTRICT (I) AND AS A CONDITIONAL USE IN COMMERCIAL LIMITED (CL) DISTRICT AND SPECIAL USE (S) DISTRICT, AND ARTICLE 8, DEFINITIONS, CREATING A DEFINITION FOR "MUSEUM", AND PROVIDING FOR SEVERABILITY, REPEALER, CODIFICATION, AND AN EFFECTIVE DATE.

WHEREAS, the City of Coral Gables is requesting an amendment to the Official Zoning Code by adding "Museum" as a permitted use in Commercial District (C) and Industrial District (I) and as a conditional use subject to public hearing review in Commercial Limited (CL) District and Special Use (S) District, and providing a definition for museum; and

WHEREAS, after notice duly published, a public hearing was held before the Planning and Zoning Board on 10.19.11, at which hearing all interested parties were afforded the opportunity to be heard; and

WHEREAS, the Board was presented with a text amendment to the Zoning Code by adding museum as a permitted use in commercially zoned districts and providing a definition for museum, and after due consideration, recommended (approval/denial) (vote: __ - __) of the amendment; and

WHEREAS, after notice duly published, a public hearing for First Reading was held before the City Commission on __. __. __ at which hearing all interested parties were afforded the opportunity to be heard; and

WHEREAS, the City Commission was presented with a text amendment to the Zoning Code, and after due consideration and discussion, (approved/denied) the amendment on First Reading (vote: __ - __).

NOW THEREFORE, BE IT ORDAINED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:

SECTION 1. The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Ordinance upon adoption hereof.

SECTION 2. The Official Zoning Code of the City of Coral Gables is hereby amended as follows (changes in ~~striketrough~~ / underline format):

SECTION 3. All ordinances or parts of ordinances inconsistent or in conflict with the provisions of this Ordinance are hereby repealed.

SECTION 4. If any section, part of section, paragraph, clause, phrase or word of this Ordinance is declared invalid, the remaining provisions of this Ordinance shall not be affected.

SECTION 5. It is the intention of the City Commission that the provisions of this Ordinance shall become and be made a part of Ordinance No. 2007-01 as amended and known as the “Zoning Code” of the City of Coral Gables, Florida, which provisions may be renumbered or re-lettered and the word ordinance be changed to “section”, “article”, or other appropriate word to accomplish such intention.

SECTION 6. If the Official Zoning Code Table of Contents or other reference portions is affected by these provisions, then changes are approved as a part of this Ordinance.

SECTION 7. This ordinance shall become effective _____, 2011.
